**SUBJECT:** December 15, 2008 Basic calculations for Equalization Assistance Report (APOR 55 - 1) and Equalization Assistance and Additional State Aid Detail Report (APOR 64)

The following items have been included in the December 15, 2008 APOR calculations:

- **ADMS data:** These student counts reflect the results of the FY2008 processing of student detail data as of November 26, 2008. Contact the Data Analysis team at (602) 542-5695 or by email at ([SchoolFinance@azed.gov](mailto:SchoolFinance@azed.gov)) if you have questions or concerns regarding the student counts. - **District Sponsored Charter School ADMS:** Student Counts are based on FY2009 estimated counts submitted by November 28, 2008.
- **Rapid Decline:** Pursuant to Laws 2008, 2<sup>nd</sup> Regular Session, Chapter 287, Section 52, no rapid decline funding shall be provided for FY 2009.
- **Audit Expense Adjustment and Type 03 HS Tuition:** All adjustments are included based on your adopted budget successfully submitted to ADE as of November 28, 2008. The chart below outlines **all** locations in which a value must be present in order for the district to receive the adjustment. - **Transportation Support Level (TSL):** Revised Route and/or Vehicle Inventory Report adjustments submitted before November 28, 2008 are reflected in the December 15, 2008 equalization calculation. Check your comparative miles report (TRAN40-2). Please contact Shirley Willis at (602) 542-8245 if you have any questions or concerns regarding this report.
- **Transportation Revenue Control Limit (TRCL):** TRCL may be capped pursuant to ARS § 15-946. The FY2009 TRCL may not exceed the FY2008 TRCL if the FY2009 TRCL would exceed 120% of the FY2009 Transportation Support Level (TSL). In the event that the TSL is greater than the TRCL, the TRCL will be set to the TSL.
- **Assessed Valuations:** TY2008 data by district and county have been revised to reflect preliminary TY2008 assessed value figures. TY2008 figures are used in the calculation of state aid in FY2009. These values have been revised for the December 15, 2008 apportionment reflecting final approved assessed values from the county Board of Supervisors as of August 2008.
- **SRP Voluntary Contributions:** Qualifying levy amounts may have changed due to the SRP Voluntary Contributions being revised for the December 15, 2008 equalization calculations.
- **Additional State-Aid (Secure Payment):** The FY2009 Additional State Aid amounts have been updated for the December 15, 2008 apportionment with data reported by the Department of Revenue.

Pursuant to A.R.S. § 15-905 budgets must be submitted electronically to the Arizona Department of Education.
