The April 2009 charter apportionment is complete. SB 1006 Adjustments: The Additional Assistance adjustments have been recalculated, the revised adjustments are included on page 2 of the April 15 CHAR64-1 reports. This adjustment is an annual adjustment, 10/12ths (or 83.33%) of the annual adjustment will be included in the April payment; the balance will be apportioned out for the remainder of the fiscal year.

In the event that you did not receive an April 2009 payment, one or more of the following may apply:

- A reduction or missing actual 100th day counts and/or 100th day SPED data.
- Banking information not submitted to the Arizona State Treasurer's Office.

All charter schools that have met the 2008-2009 school year SAIS 40th Day or 100th Day reporting requirement of 40 or 100 session days, plus 13 ADE business days on or before 5:00 PM on March 20, 2009 have been funded strictly from the actual 40th Day data. It is the responsibility of each charter school to verify that the ADMS46-1 Report for 40th day and 100th day if applicable and the SPED28-1 Report for Special Education census data posted on their web page (<http://www.ade.az.gov/districts>) accurately reflects the data submitted. LEAs are required to submit student level data to SAIS at least once every 20 school days per A.R.S. §15-1042(G). Please take the time to confirm that the charter is SAIS-reporting compliant and that all 2008-2009 SAIS-related data is current and accurate.
